Accordingly, being fully advised in this matter, the Court finds Defendant is in default and hereby **ORDERS** the following:

1. Plaintiff's request is **GRANTED**;
2. Defendant is declared to be a vexatious litigator under Ohio Revised Code §2323.52;
3. Defendant is prohibited from instituting, continuing, or making any application in:
 - a. Any legal proceedings in the court of common pleas, municipal court, or county court without first seeking and obtaining leave of court to proceed; and
 - b. Any appeal without first seeking and obtaining leave of court to proceed.
