This matter came before the Court on Defendant Carlos Co's motion to declare Plaintiff Chia Chi Ho a vexatious litigator pursuant to R.C. 2323.52. "Vexatious litigator" means any person who has habitually, persistently, and without reasonable grounds engaged in vexatious conduct in a civil action or actions, whether in the court of claims or in a court of appeals, court of common pleas, municipal court, or county court, whether the person or another person instituted the civil action or actions, and whether the vexatious conduct was against the same party or against different parties in the civil action or actions." R.C. 2323.52(A)(3).
