This cause came on for consideration on February 9, 2012, upon the Plaintiff's Motion for Default Judgment and Complaint seeking Defendant, Robert L. Grimm, to be declared a "vexatious litigator" pursuant to Revised Code 2323.52.

This Court finds that Defendant has engaged in habitual and persistent vexatious conduct against the Plaintiff in that they have without reasonable grounds: continued to repeatedly raise the legal issues previously litigated or arising out of the litigation bearing case no CV 06-609684 filed in the Cuyahoga County Common Pleas Court entitled Parkview Federal Savings Bank vs. Robert L. Grimm, et al., which Mr. Grimm appealed four times to the Eighth District Court of Appeals and twice to the Ohio Supreme Court. Mr. Grimm also filed related suits against an employee of Parkview Federal Savings Bank, as well as a suit against the appraisers who appraised his property.

This Court further finds that Defendant has engaged in the conduct set forth in Plaintiffs' Complaint merely to harass or maliciously injure the Plaintiff and Defendant's conduct is not warranted under existing law and cannot be supported by a good faith argument for an extension, modification, or reversal of existing law and is designed solely for the purposes of harassment and delay.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED, that Plaintiff's Motion for Default Judgment is hereby granted in its favor and against Defendant, Robert L. Grimm, who is hereby declared a "vexatious litigator" and is hereby barred from filing lawsuits against the Plaintiff in a court of claims, court of common pleas, municipal court, county court, or any appellate court without prior written permission from this Court, pursuant to Revised Code 2323.52(F).


