## **GUIDANCE – EXTERNAL ROSTERS**

- At the top of the roster, the Court's signature or logotype appears in the center.
- The title of the Board, Commission or Advisory Committee in bold, capital letters is centered below the Court's signature or logotype.
- Roster Year appears in bold, capital letters below the title.
- Information on Members is displayed across three columns: Member, District/Designation, and Terms.
- Chair or Co-Chairs should appear first on the roster followed by Vice-Chair, if applicable. The other Members' names appear on the roster in alphabetical order.
- The name, title, office and contact information, including email address, for the individual designated as staff liaison appear at the end of the roster.
- The title of the Board, Commission or Advisory Committee, the Roster Year, and the last revision date should appear italicized in the footer of the roster, justified to the right margin.
- In the Member column, after the Member's name, the office/position and their city, village or township should appear.
- The District/Designation column reflects whether the member's service on the Board, Commission or Advisory Committee is tied to a specific position or geographic area. If the Member serves no specific district or designation, then he /she should be designated as At-Large.
- The Terms column reflects the current full or partial term and notes the dates of service.
- If a Member is serving as Chair, a Co-Chair or Vice-Chair, the position and dates of that service should appear below the terms of service to the Board, Commission or Advisory Committee.
- If a Member leaves a Board, Commission or Advisory Committee for any reason (resignation, removal, etc...), then that change is reflected by removal of that person on the roster.
