**JUDGMENT ENTRY**

This matter came on for consideration upon the Plaintiff's Motion for Default Judgment and supporting Affidavit.

The Court finds that Defendant, having been duly served according to law, has failed to plead or defend, as required, by September 9, 2009. Plaintiff is, therefore, entitled to default judgment as a matter of law.

IT IS THEREFORE ORDERED that the Defendant, Ronald Godec, is hereby declared a vexatious litigator as that term is defined in O.R.C. §2323.52(A)(3).

IT IS FURTHER ORDERED that effective as of the date of this Order, the Defendant is prohibited from instituting legal proceedings in the court of claims, a court of common pleas or any division thereof, a municipal or county court without first obtaining leave of that court to proceed.

IT IS FURTHER ORDERED that effective as of the date of this Order, the Defendant is prohibited from continuing any legal proceedings that the Defendant has instituted in any of the courts above specified prior to the entry of this order without first obtaining leave of the court to proceed.

IT IS FURTHER ORDERED that effective as of the date of this Order, the Defendant is prohibited from making any application other than an application for leave to proceed under division (F)(1) of O.R.C. §2323.52, in any legal proceedings instituted by the vexatious litigator or another person in any of the courts above specified.

IT IS FURTHER ORDERED that this order shall remain in full force and effect until further Order of this Court.


IT IS FURTHER ORDERED that the Clerk of Courts shall send a certified copy of this Order to the Supreme Court of Ohio for publication as set forth in O.R.C. §2323.52(H).
