SPECIALIZED DOCKETS PRACTITIONERS ATTEND CONFERENCE

More than 300 professionals involved in specialized dockets in courts across Ohio met Thursday for training sessions and to learn innovative and effective strategies from each other. The fifth annual conference of the Ohio Specialized Dockets Practitioner Network included national speakers and workshops on topics such as evaluating the effectiveness of drug court, jail services for mentally ill offenders and mental health services for veterans. Supreme Court of Ohio Chief Justice Thomas J. Moyer and Director Angela Cornelius Dawson of the Ohio Department of Alcohol and Drug Addiction Services (ODADAS) welcomed the 340 participants, including judges, attorneys, law enforcement personnel, treatment providers and counselors. OHIO COMMITS \$6.4 MILLION FOR NEW BREATHALYZERS THAT FACE LAWSUITS ACROSS THE COUNTRY

State officials on Monday agreed to spend \$6.4 million on a controversial brand of portable breathalyzer machines that have resulted in hundreds of drunken driving cases across the country being dropped. In fact, the president of the company that makes the Intoxilyzer 8000, faces a contempt hearing next week in Arizona for not complying with a judges order to reveal the machines software to prove whether it produces reliable blood-alcohol readings. EARLY PRISON RELEASE POSSIBLE FOR 256 CRACK DEALERS

The federal probation office has determined that 256 crack-cocaine dealers in the Southern District of Ohio are probably eligible for early release from prison under a change in federal sentencing guidelines. The court district covers the southern half of Ohio, including Columbus, Dayton and Cincinnati. "That number is pretty close to being reliable. ... NEW DRUG COURT THE SITE OF MANY SUCCESSES

The Scioto County Drug Court has seen a number of successes in its three years of existence. The court is operated by volunteers from various agencies that have seen it work in other cities and want to make sure it works in Scioto County. Judge William Marshall was a former Portsmouth City prosecutor for 13 years. "My philosophy when I was prosecutor, when it came to drug addicts, was to lock them up and throw away the key. That's what I kept going for. When I became Municipal Court Judge, within a year or two Daniel Cassity appeared at my door," Marshall said. [More...](#)

SEAN LEVERT'S DEATH MIGHT HAVE BEEN AVOIDED IN COLUMBUS, CINCINNATI AREA JAILS

If Sean Levert had been jailed in March in either of Ohio's two other major urban-county jails instead of Cuyahoga County's, he might still be alive. Officials at the Franklin and Hamilton county jails both said their facilities have policies that would not have denied R&B singer Levert his doctor-prescribed anxiety medication, as jail staff at the Cuyahoga County Jail did during Levert's last six days of life.

FREE MENTAL HEALTH TRAINING FOR JAIL AND COURT PERSONNEL

A core part of the National Alliance on Mental Illness of Ohio (NAMI Ohio) mission is to provide free training to dispel the myths about mental illness and to promote understanding. NAMI Ohio provides free one-day training for jail and court personnel who regularly encounter individuals with mental illness. Participants include parole, probation, corrections officers, public defenders, prosecutors, bailiffs, school personnel, and program coordinators who work with court involved youth. Attendees will learn to identify major mental illnesses and their typical characteristics; techniques to manage individuals with mental illness; how to better prevent crisis situations and how to handle them when they do occur; how to identify risk factors for suicide in correctional settings; about opportunities to expand court based jail diversion programs for individuals with mental illness. Attendees will also benefit from a presentation by an officer trained in Crisis Intervention Team training (a 40 hour academy providing de-escalation training for first responders). Ultimately, it is the goal of this training for participants to come away with a better understanding of what it might be like to have a mental illness. RESEARCH

CO-OCCURRENCE OF SUBSTANCE USE BEHAVIORS IN YOUTH

Examines the prevalence and overlap of substance-related behaviors among youth, making comparisons based on age group, gender, and race/ethnicity. Findings reported in this Bulletin are drawn from the first two stages of the 1997 National Longitudinal Survey of Youth, which gathered self-reports from a nationally representative sample of youth ages 12–17 in 1997 and 1998. The data are derived from questions survey participants answered regarding their alcohol and drug use during the previous 30 days, including the frequency of their consumption, the types of drugs used, and whether they had sold drugs. The central finding was that, given one substance-related behavior, other substance-related behaviors became much more likely.
