

## SUMMIT BOARD TO HONOR FOUR ADVOCATES IN MENTAL HEALTH, ADDICTION SERVICES

The Summit County Alcohol, Drug Addiction and Mental Health Services Board will honor four advocates at its annual appreciation luncheon on Wednesday. Those receiving awards are county Juvenile Court Judge Linda Tucci Teodosio, Barbara Medlock, Georgette Kistner and Dr. Andrew DiBartolomeo. The board established awards in 2007 in honor of individuals who are recognized as being trailblazers and advocates in the mental health and addiction services field. <u>More...</u>

#### SIX PEOPLE GET STAR TREATMENT FROM JUDGE

Six people who have been charged through the county Municipal Court pledged Friday to take charge of their mental illnesses and responsibility for their actions. The second class of the Successful Treatment And Recovery (STAR) program, which was enacted in January 2007 by Judge Carol Robb, graduated Friday, each giving personal testimony of how the program has changed him or her for the better. Defendants who complete the intense probation program's requirements must then go on non-reporting probation for one year but otherwise have their fines and jail sentences excused. A total of 38 defendants have entered the program and, as of Friday, 10 have completed it. <u>More...</u>

## JUDGE WEIGHS REDUCED SECURITY FOR COP KILLER WHO IS MENTALLY ILL

A judge must determine whether to grant more freedom to a Cleveland cop killer whose psychosis has been under control with medication for the 32 years he has spent in state hospitals. Dozens of police officers packed the courtroom of Cuyahoga County Common Pleas Judge David Matia on Friday morning, in opposition of Anthony Roden's permanent transfer from Northcoast Behavioral Healthcare to a residential treatment facility. <u>More...</u>

## UNION COUNTY SEEKING A MENTAL-HEALTH LEVY

When the state budget ripped about \$600,000 from Union County mental-health programs, local officials had only a few weeks to decide whether to ask voters for help. For Mike Witzky, director of the Union County Mental Health and Recovery Board, there was no choice. So he crunched the numbers and was able to secure the backing of the Union County commissioners to get a tax issue on the ballot. <u>More...</u>

## SOBER POLICY ON POT

Jittery medical marijuana users can stop looking over their shoulders. The Obama Administration has, finally, instructed federal authorities to stop arresting folks for medical consumption of pot. During the Bush years, Americans suffering various maladies in 13 states with medical marijuana laws on the books had good reason to be paranoid. Federal agents were zealous about enforcing federal anti-marijuana laws even when state governments from California to Rhode Island approved its limited and controlled use. <u>More...</u>

## WRONG-WAY DUI DRIVER ORDERED INTO DRUG REHAB

A judge ordered drug treatment instead of prison time for a woman who drove drunk the wrong way on I-71 on New Year's Day with her toddler in the back seat. Lindsey J. Thompson, 24, of Columbus, pleaded guilty on Friday to one count of cocaine possession at the time of the arrest. Delaware County Common Pleas Judge W. Duncan Whitney said he will drop the felony drug charge if she completes a drug-treatment program. <u>More...</u>

### QUESTIONS LINGER IN INMATE'S HANGING DEATH

One year after he was found dead in a Newton Falls holding cell, Zackary Dunn's mother said she still is not satisfied with the investigation that ruled Dunn's death a suicide that could not have been prevented. Traci Martinez of Florida said she wants the investigation into her son's death reopened, saying that her son could not have hanged himself if he was found with wrists and ankles bound, as the coroner reported. <u>More...</u>

## JUDGE'S DAUGHTER FACES DRUG CHARGE

Union County Common Pleas Judge Don Fraser has watched many an accused drug user pass through his court, and he's tried to levy justice and help them. Since taking office in February, Fraser has spoken often about how heroin in particular has a stranglehold on his community, and how local officials have been right to organize a task force to tackle it. But now, the drug problem has reached Fraser's own home. <u>More...</u>

## ATTORNEY GENERAL ENDORSES VA HOSPITAL PROPOSAL

Ohio Attorney General Richard Cordray has asked the U.S. Department of Veterans Affairs to transform the former Doctors Hospital in Perry Township into a full service veterans hospital. "By incorporating the Doctors Hospital facility, you would make available an additional option for veterans on the east side of the state who now must drive to Ohio's northern border to receive care in Cleveland," Cordray wrote in an Oct. 19 letter to VA Secretary Eric Shinseki. <u>More...</u>

## OHIO YOUTH ASSESSMENT SYSTEM TRAININGS

The Department of Youth Services is pleased to announce the completion of the Ohio Youth Assessment System. Over the past three years, DYS has partnered with University of Cincinnati (UC) to develop a risk, needs and responsivity assessment specific to Ohio's youth. With the help of the pilot counties and facilities UC was able to collect and analyze data in order to develop a system of assessments that expand as a youth moves deeper into the system. The OYAS is made up of five instruments (Diversion, Detention, Disposition, Residential and Reentry) which will assist juvenile justice professionals in making the best decisions for youth and creating a common language across systems.
