The online catalog lists periodicals in the collection by title and call number. Most periodicals issued in book format are on the 14th Floor in alphabetical order. Periodicals similar to newsletters are shelved by call number throughout the rest of the collection, and those on microfiche/microfilm are stored in the AV Room on the 12th Floor. Online periodicals can be accessed on library computers.

Index to Canadian Legal Literature
(Westlaw - ICLL)

1985 - present: Subscription-based. Available through Westlaw.

Legaltrac (Infotrac) (AI 3 I54 INTERNET)

1980 - present: Subscription-based. Available on library computers.

Legal Resource Index (Lexis - LGLIND)

1977 - present: Subscription-based. Available on library computers.

Westlaw - LRI

1980 - present: Subscription-based. Password required for use.

Criminal Justice Periodical Index
(REF Z 5118 C9C7)

1976 - 1998: British and Canadian journals.

Current Index to Legal Periodicals (KF 8 C78)

2002 - present: Recent articles. Updated weekly. Also available on Westlaw (CILP most recent eight weeks).

Current Law Index (KF 8 C8)

1980 - present: The paper form of Legaltrac. Does not index legal newspapers.

European Legal Journals Index (K 33 E87)

1993 - 2002: Journals published throughout Europe in English.

Index to Foreign Legal Periodicals (K 33 I54)

1984 - 2001: Indexes more than 500 legal journals. Excludes the United States and the British Commonwealth. Also available on Westlaw (IFLP current data).

Index to Legal Periodicals & Books (KF 8 I4)

1908 - present: Indexes more than 500 legal journals. Also available on Lexis (ILP 1978-present) and Westlaw (ILP 1981-present).

Index to Periodical Articles Related to Law
(KF 8 I43)

1958 - 2004: Law articles in nonlegal periodicals.

Jones-Chipman Index to Legal Periodical
Literature (KF 8 I4)

1888 - 1937.

Kindex (K 33 K56)

1965 - 2001: Periodicals concerning children and the juvenile justice system.

Legal Journals Index (K 33 L46)

1986-1999: Journals published in the United Kingdom.

National Law Journal

(Reading Room and AV Room)

Recent issues on paper. Earlier issues on microfiche. Features surveys of select new legal literature. Also available on Lexis (NTLAWJ).

Readers' Guide to Periodical Literature
(AI 3 R48)

1973 - 2003: General index for periodicals.

LEGAL PERIODICALS IN PRINT

Legal periodicals are shelved on the 14th Floor in alphabetical order, with "A" starting on the north end and "Z" ending on the south end. Periodicals that have changed titles are shelved with the old and new titles together; therefore, the alphabetical order is approximate. The call number is the final determination of the order. The most frequently used range of call numbers is K 1 – K 30 (law periodicals A to Z). Other call numbers are interfiled to maintain

alphabetical order. Bar Association annual reports are shelved alphabetically in their own sequence at the south end of the floor.
