New Business: Data Dashboard Debut

During the meeting, hosted via webinar, staff from the Court Services Division of the Supreme Court of Ohio presented an updated draft version of a data dashboard powered by Tableau. This dashboard visually displays the 2.4 million data points collected annually by the Supreme Court of Ohio from local courts. The dashboard is a graphical demonstration of local court caseloads and terminations, from a courtwide and statewide view. This digital platform also includes interactive maps which display information in an easy-to-access manner. The dashboard is proposed to be a public facing tool that could replace the printed version of the annual Ohio Courts Statistical Report.

During the committee's review of the dashboard, several additional changes were suggested, including a "light bulb" where users could click to find definitions for terms used in the data dashboards and find answers to questions regarding the statistical reporting requirements for Ohio courts.

The Committee recognized the need to educate local court administrators and judicial officers about the dashboard and allow some time for courts to review their stats and, as needed, receive training from the Case Management Section regarding the Instructions for Statistical Reporting.

Staff from the Court Services Division have presented the dashboards to several audiences at association meetings and the response has been overwhelmingly positive. The dashboards are slated to go live in early 2019.
