- 2. Continuing any legal proceedings that Defendant instituted in the court of claims, court of common pleas, municipal court, or county court prior to the entry of this Order; or

3. Making any application, other than an application for leave to proceed under R.C.

2323.52(F)(1), in any legal proceeding instituted by Defendant or another person in the

court of claims, court of common pleas, municipal court, or county court.
