Petitioner Stormy Watkins has filed six petitions for a civil stalking protection order against Respondent Kimberlee D. Shields in cases SK1300428, SK1300468, SK1300477, SK1301353, SK1400068, and SK1400159. Five of those cases have been previously dismissed because Stormy Watkins failed to timely appear for the hearing. Case (3K1400159 is currently pending before the court and remains to be litigated. Each and every time Stormy Watkins files a petition hearings are held, service is issued, and administrative processes are instituted in accordance with Ohio law. Stormy Watkins' has put tremendous strain not only on Respondent Kimberlee Shields, but precious county resources as well. Due to her persistent failures to appear and subsequent re-filings of the same action, the court finds Stormy Watkins is a vexatious litigator.

Pursuant to O.R.C. 2323.52, this court finds that Stormy Watkins is prohibited from doing the following without first obtaining leave of court to proceed: (a) Instituting legal proceedings in a court of common pleas; (b) Continuing any legal proceedings that the plaintiff had instituted in a court of common pleas prior to the entry of this order;

(c) Making any application, other than an application for leave to proceed pursuant to O.R.C. 2323.52(F), in any legal proceedings instituted by the plaintiff or another person in a court of common pleas.

Stormy Watkins may file pleadings in, appear, and continue litigating case SK1400159 without leave of court. Stormy Watkins must obtain leave of court before

filing or instituting any future cases.
