This matter originated in this court on the filing of a report by the Commission on Continuing Legal Education (the "commission") pursuant to Gov.Bar R. X(6)(A)(1)(b) and (2)(d). Pursuant to the order to show cause, respondent has tendered payment in the amount of the recommended sanction, in lieu of filing objections. Upon consideration thereof,

IT IS ORDERED by the court that the sanction of \$[Sanction Amount] is hereby imposed upon the respondent and payment of the sanction is acknowledged.

IT IS FURTHER ORDERED by the court that this order shall not be considered a disciplinary order pursuant to Gov.Bar R. V or Gov.Bar R. X(6)(H).

IT IS FURTHER ORDERED by the court that the Clerk shall send this order by certified mail to the respondent at the address registered with the Attorney Registration Section under Gov.Bar R. VI; that, if this order is returned as undeliverable or unclaimed, the Clerk shall send it by regular mail; and that service of this order in accordance with the foregoing shall be deemed effective service.

IT IS FURTHER ORDERED that, payment of the sanction notwithstanding, respondent shall comply with the requirements imposed by Gov.Bar R. X for the 2003-2004 reporting period. See CLE Reg. 503.4.

Gov.Bar R. VI(1)(A) requires all attorneys admitted to the practice of law in Ohio to file a Certificate of Registration for the 2005/2007 attorney registration biennium on or before September 1, 2005. Section 6(A) establishes that an attorney who fails to file the Certificate of Registration on or before September 1, 2005, but pays within ninety days of the deadline, shall be assessed a late fee. Section 6(B) provides that an attorney who fails to file a Certificate of Registration and pay the fees either timely or within the late registration period shall be notified of noncompliance and that if the attorney fails to file evidence of compliance with Gov.Bar R. IT IS FURTHER ORDERED that respondent shall not be reinstated to the practice of law in Ohio until (1) respondent files a Certificate of Registration for the 2005/2007 attorney registration biennium and all other biennia for which respondent has not registered; (2) respondent pays all applicable registration fees;
