On January 25, 2011, Plaintiff Robert Martin filed a pleading in this Court entitled "Declaratory/Injunctive Relief." This pleading is very similar to the pleading filed by Plaintiff in Case No. 2010-CI-0558, filed December 29, 2010.

This Court found in Case No. 2010-CI-0558 that Robert Martin has been declared a vexatious litigator pursuant to O.R.C. Section 2323.52 by the Wayne County Probate Court. The Court further found no evidence that Mr. Martin sought leave with said court to file that complaint.

Based on its previous determination in Pickaway County Case No. 2010-CI-0558, this Court *sua sponte* **dismisses** the instant action.

Furthermore, this Court has carefully considered the requirements of O.R.C. Section 2323.52 with regard to the fact that this is Mr. Martin's fourth action filed in this Court, and that Mr. Martin has habitually, persistently, and without reasonable grounds engaged in vexatious conduct in civil actions in this Court, as well as several other courts, and has been twice declared a vexatious litigator, hereby finds Robert Martin to be a vexatious litigator.


