
Consistent with the order of the Court of Appeals for the Eighth District of Ohio in Peter Hull v. Ivan Sawchyn, Case No. 78181, this Court orders as follows:

1. That Ivan Sawchyn is found to be a vexatious litigator, in accordance with Ohio Revised Code Section 2323.52.
2. Ivan Sawchyn is prohibited by the Court to do any of the following without first obtaining leave of court to proceed:
 - (a.) Instituting legal proceedings in the court of claims or in a court of common pleas, municipal court, or county court;
 - (b.) Continuing any legal proceedings that Ivan Sawchyn has instituted in the court of claims or in a court of common pleas, municipal court, or county court prior to the entry of this order;
 - (c.) Making any application, other than an application for leave to proceed, in any legal proceedings instituted by Ivan Sawchyn in the court of claims or in a court of common pleas, municipal court, or county court.



3. This order shall remain in force for an indefinite period of time. See R.C. § 2323.52(E).
4. The Clerk of the Cuyahoga County Common Pleas Court shall send a certified copy of this order to the Ohio Supreme Court for publication. See R.C. § 2323.52(H) In addition, any clerk of the court of claims, court of common pleas, municipal court, or county court is directed to refuse any filing by Ivan Sawchyn if Ivan Sawchyn does not comply with the directives of Section 2 of this order.
5. Any proceeding instituted or continued, or any application made by Ivan Sawchyn without leave of the Cuyahoga County Common Pleas Court to proceed shall be dismissed

IT IS SO ORDERED.


