93-1238. State ex rel. Semik v. Cuyahoga Cty. Bd. of Elections.  
In Prohibition. This cause originated in this court on the filing of  
a complaint for a writ of prohibition regarding an election matter and  
was considered in a manner prescribed by law. Upon consideration  
thereof,

IT IS ORDERED by the court that respondents' motion for summary  
judgment be, and hereby is, granted.

IT IS FURTHER ORDERED by the court that, for the reasons stated  
in the opinion to follow, the writ of prohibition be, and hereby is,  
denied.
